1. All work in the show must be original and made by the artist.
2. Artists must accompany their work and be present at their booth throughout the show. Artists are to provide their own tents, tables, and displays within their 12' x 10' booth space. Power is not available to booths. All exhibits must remain in place for the entire show, from 9am to 5pm. Tinglewood Festival is a "rain or shine" event.
3. Booth setup will be Saturday morning, September 12, 2026, from 7 am until 8:30 am. Volunteers will be on hand to assist artists who want help with unloading, setup and with take down.
4. The booth exhibitor is responsible for collecting and remitting city, county and state sales taxes.
5. Neither the Tinglewood Festival, Montevallo Chamber of Commerce, City of Montevallo, Montevallo Arts Collaborative nor Montevallo Main Street are responsible for the safety of exhibits while in transit or in the exhibition area. Booths for artists need to be sturdy enough to withstand crowds and weather.
6. We reserve the right to prohibit any exhibit or part of an exhibit or restrict any activity or conduct deemed undesirable.
7. If accepted for the Tinglewood Festival, the artist's payment of booth fee is considered a commitment to the show. The booth fee is "non-refundable".
8. You are not accepted until you get a confirmation.
